- **2.** The convention rooms will be paid at double occupancy for the three days of the convention (October 21st, 22nd 23rd with check out on the 24th). The rate this year is \$270.00 double occupancy. If you wish to have a room by yourself, you will be responsible to pay in advance of the convention one-half of the room rate plus tax.
- **3.** Reimbursement for travel, traveling by car will be reimbursed at a maximum of \$130.00. This will cover the following: mileage by odometer/map quest to and from home to San Diego and San Diego to home. Map quest or odometer readings must be given for mileage reimbursement.
- **4.** One (1) days lost wages at your regular rate of pay for a scheduled day or at WAHR on a scheduled day off up to eight (8) hours.
- **5.** The other two days you will not be compensated. You need to ask for union leave, PTO/vacation or educational leave.

A Message from Greal Yumul, RN Workplace Safety Officer

Highest department injuries for the month of June were the EVS and Laboratory Departments.

EVS had three injuries for month of June. Two of these injuries were back injuries. The question is how can we prevent these injuries keep from happening? One suggestion was to stretch prior to starting work. Please be mindful of your environment and body mechanics.

The laboratory department also had 3 injuries for the month of June and 1 in July. Our laboratory has one of the highest rates of injuries our region. Most of these injuries are caused by repetitive movement. Please remember to use proper body mechanics. I know it sounds simple but it is effective when used properly.

What can we do to turn things around?

Emergency Room is the gold standard since this is the department that has the most patient turn around. However, they manage to keep injures very low. Last year, there were zero injuries for year 2011. How did they achieve this? Communication with staff and awareness of surroundings. ER managers are constantly doing rounds to make sure that the ER department is safe from any needles, wet floors, etc. They communicate with staff regarding any issues, especially when it comes to safety.

An issue in 4500 unit was brought up regarding cleaning rooms especially at night for EVS. It is on our policy that EVS cannot remove the heavy equipment. There was numerous staff from 4500 asking why do the nurses have to clean out everything prior to EVS cleaning. The policy states that the staff on that

unit is responsible for cleaning and taking out used equipment prior to EVS cleaning the rooms.
