A Message from Angela Gonzalez-Acosta, RN Hospital President

I cannot explain how much anger and frustration I feel right now. Many employees at South Bay received a horrible notice on Friday, November 16 and Monday, November 19 that their positions are being eliminated! This has caused people to feel a mix of emotions like anxiety, sadness, tearfulness, and worry. Kaiser notified us - your local officers, last minute of their decision. The majority of affected nurses are from inpatient areas. I have been present supporting nurses who are affected.

Kaiser made a drastic decision to get rid of staff positions without considering our contract rules. I do

not agree with the process of elimination.

Affected staff feels like they were just a number being picked and do not feel appreciated for all of the time and hard work they have invested in the company. We will continue to work hard for our members and I will be rounding, texting, and e-mailing you any updates that we have and any directives we get from Ken, our UNAC/UHCP president. All South Bay officers and stewards met with Ken on Monday, November 26 in person. We will be informing you on what to do next. We will have to stand strong and be there for each other because no one knows what Kaiser will do next.
